



Hand Washing

Policy Statement

Handwashing will significantly reduce the risk of the spread of infectious diseases as well as providing a hygienic environment for children, families, visitors and staff.

Implementation

- Staff will observe and role model health and hygiene practice, compliant with guidelines set by relevant authorities.
- Services encourage all to sanitise and/or wash their hands on arrival to the service, the same on departure from the service.
- Hand washing procedures are displayed throughout the service.
- Washing hands with warm soapy water is preferable; however, sanitiser is available across the service.

Procedure

- Wet hands with running water.
- Use liquid or foam soap and spread over hands.
- Rub hands vigorously. Wash hands, paying particular attention to palms and back of hands, between fingers, under fingernails and around wrists.
- Rinse hands thoroughly.
- Turn off tap with paper towel, dispose of immediately.
- Pat hands dry with a clean piece of paper towel.
- Hand washing education is included in children's programs.
- Children will be supervised to ensure they develop good hand washing habits.
- Staff are to wash/sanitise their hands:
 - On arrival to the service, prior to commencing work, prior to eating, at the conclusion of breaks and on departure from the service;
 - Prior to and after administering medication and First Aid;
 - After visiting the toilet or using a tissue;
 - Before starting a nappy change routine;
 - After each nappy change, changing a child's soiled clothes, toileting or bathing children;
 - After wiping a nose or handling bodily fluids;
 - After touching hair and face when serving food;
 - Prior to and after handling raw food or utensils which have come in contact with raw food;
 - After garbage disposal;
 - Prior to and after preparing and serving food and bottles;
 - After removing gloves;
 - After smoking a cigarette;



- When moving between rooms;
- Prior to and after applying sunscreen or other lotions to one (1) or more children.
- After gardening or using the compost or worm farm;
- After handling animals; and
- After any other unhygienic practice.
- Children are to wash/sanitise hands:
 - On arrival to and departure from the service;
 - Prior to eating;
 - After going to the toilet;
 - After touching nose secretions and using a tissue;
 - Prior to participating in cooking activities;
 - After a nappy change;
 - After gardening or assisting with the use of the compost or worm farm;
 - After handling animals; and
 - Any other unhygienic practices.
